4.1 Description of first-aid measures

If inhaled	If not breathing, give artificial respiration. Remove from exposure, lie down. Causes burns by all exposure routes. Product is a corrosive material. Use of gastric lavage or emesis is contraindicated. Possible perforation of stomach or esophagus should be investigated: Ingestion causes severe swelling, severe damage to the delicate tissue and danger of perforation
