General advice

If inhaled	Remove to fresh air. Call physician.
In case of skin contact	Take off immediately all contaminated clothing. Rinse skin with water/ shower. Call a physician immediately.

If swallowed	Make victim drink water (two glasses at most), avoid vomiting (risk of perforation). Call a physician immediately. Do not attempt to neutralise.

4.2 Most important symptoms and effects, both acute and delayed

Causes burns by all exposure routes. Product is a corrosive material. Use of gastric lavage or emesis is contraindicated. Possible perforation of stomach or esophagus should be investigated. Ingestion causes severe swelling, severe damage to the delicate tissue, and danger of perforation.
