SECTION 4: First aid measures

4.1 Description of first-aid measures

General advice

- If inhaled** Remove to fresh air. If not breathing, give artificial respiration. Do not use mouth-to-mouth method if victim ingested or inhaled the substance; give artificial respiration with the aid of a pocket mask equipped with a one-way valve or other proper respiratory medical device. Immediate medical attention is required. Risk of serious damage to the lungs (by aspiration).
- In case of skin contact** Wash off immediately with plenty of water for at least 15 minutes. Immediate medical attention is required.
- In case of eye contact** Rinse immediately with plenty of water and seek medical advice.
- If swallowed** Do NOT induce vomiting. Call a physician or poison control center immediately. If vomiting occurs naturally, have victim lean forward.

4.2 Most important symptoms and effects, both acute and delayed

Difficulty in breathing. Symptoms of overexposure may be headache, dizziness, tiredness, nausea, and vomiting.

SECTION 5: Firefighting measures

5.1 Extinguishing media
